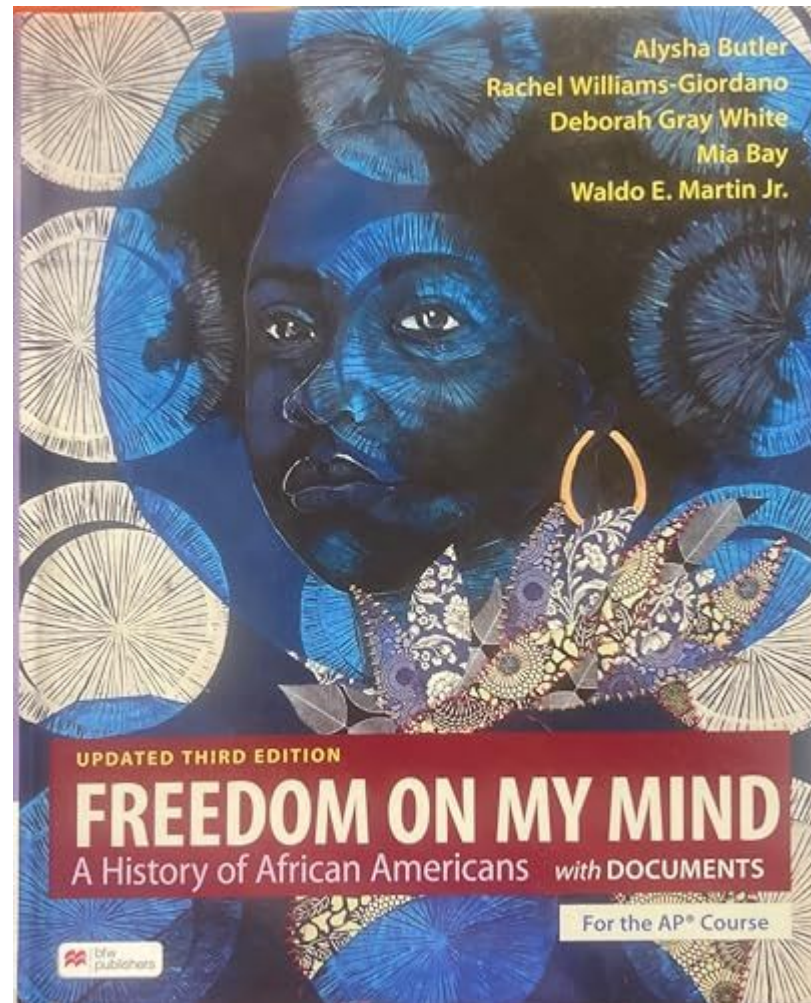

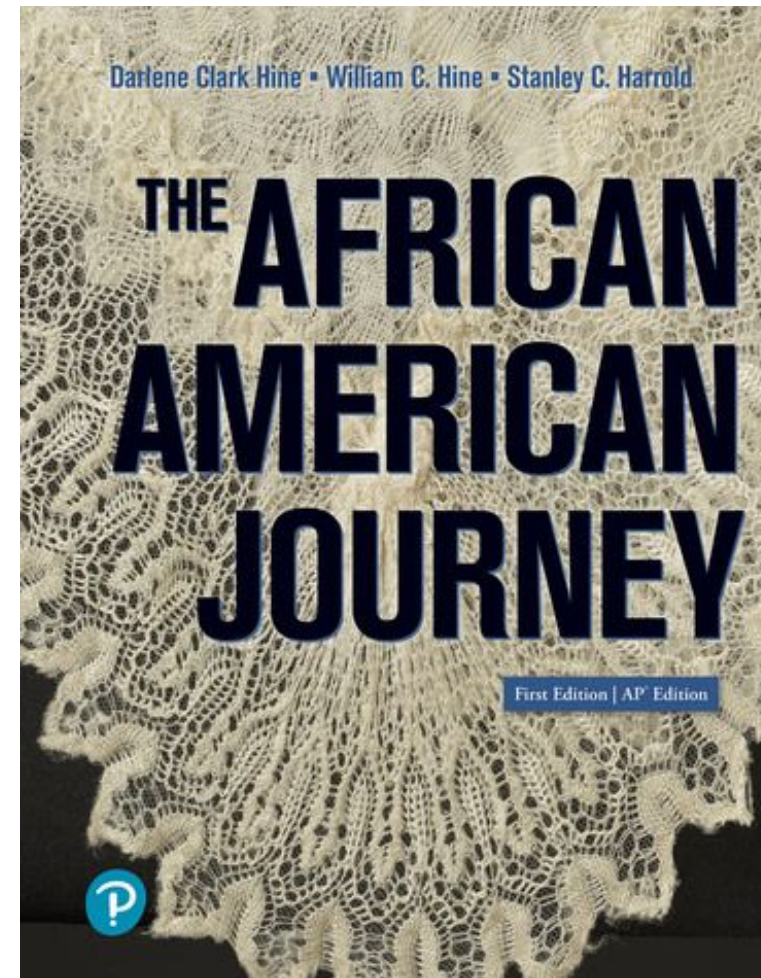
The Process

- **Summer- Fall 2025: *Course Added***
 - AP African American Studies was added to the Program of Study and approved at the January 2026 school board meeting.
- **Winter 2026: *Textbook Samples Requested***
 - Coordinator requested samples from publishers listed on College Board's website for review.
- **March- April 2026: *Committee Evaluation of Textbooks***
 - Committee used the VDOE rubric to evaluate 3 textbooks from College Board's list and decided official recommendation for adoption.

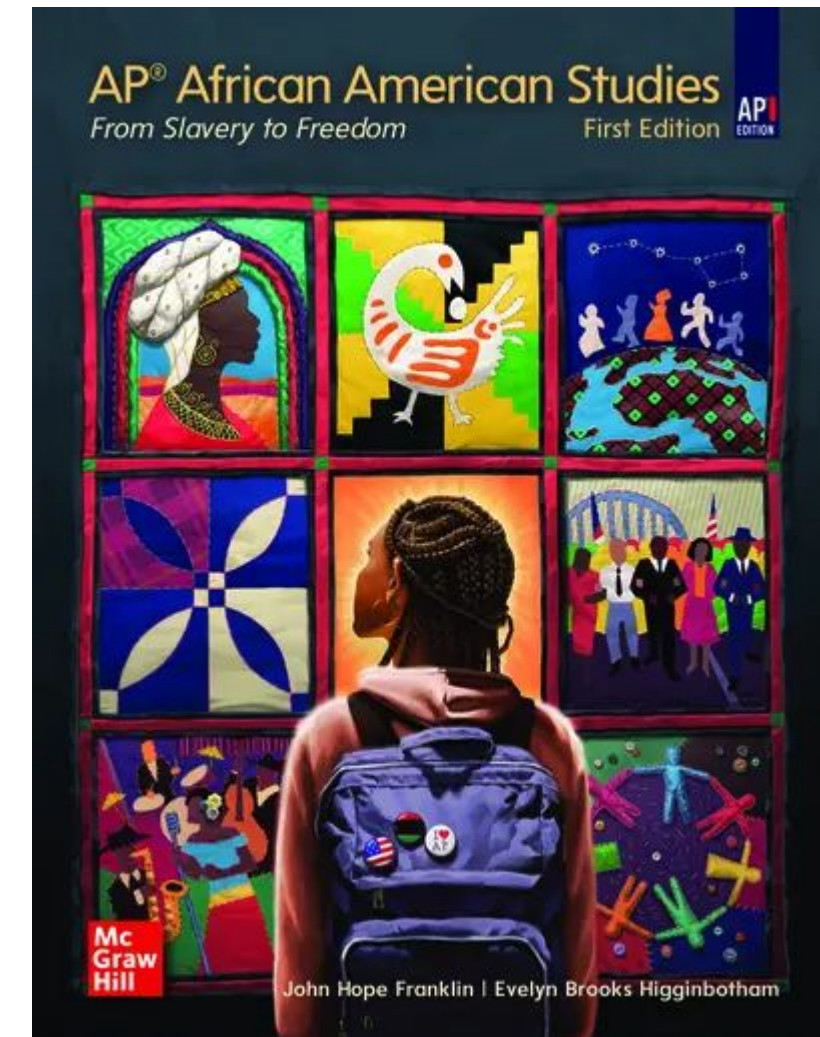

VDOE Textbook Evaluation Tool:

9 Criteria :

1. Age Appropriateness
2. Textbook organization
3. Textbook formatting
4. Writing style and appropriate language
5. Information sources
6. Integration of skills and concepts
7. Lack of bias and stereotyping
8. Diverse perspectives and representation
9. Digital Considerations

Each Criterion receives a **A (adequate)**, **L (limited)**, or **N (no evidence)**

Here are the scores for each textbook:

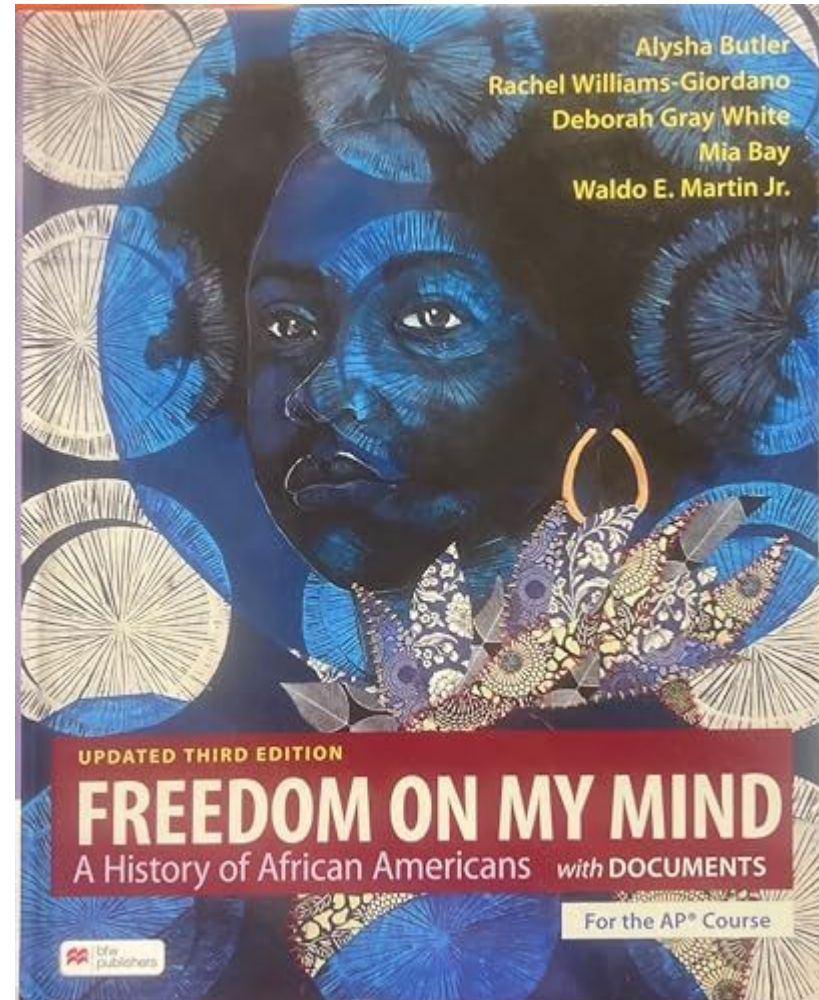
- Freedom on my mind (Butler et al., 2025): **108 (perfect score)**

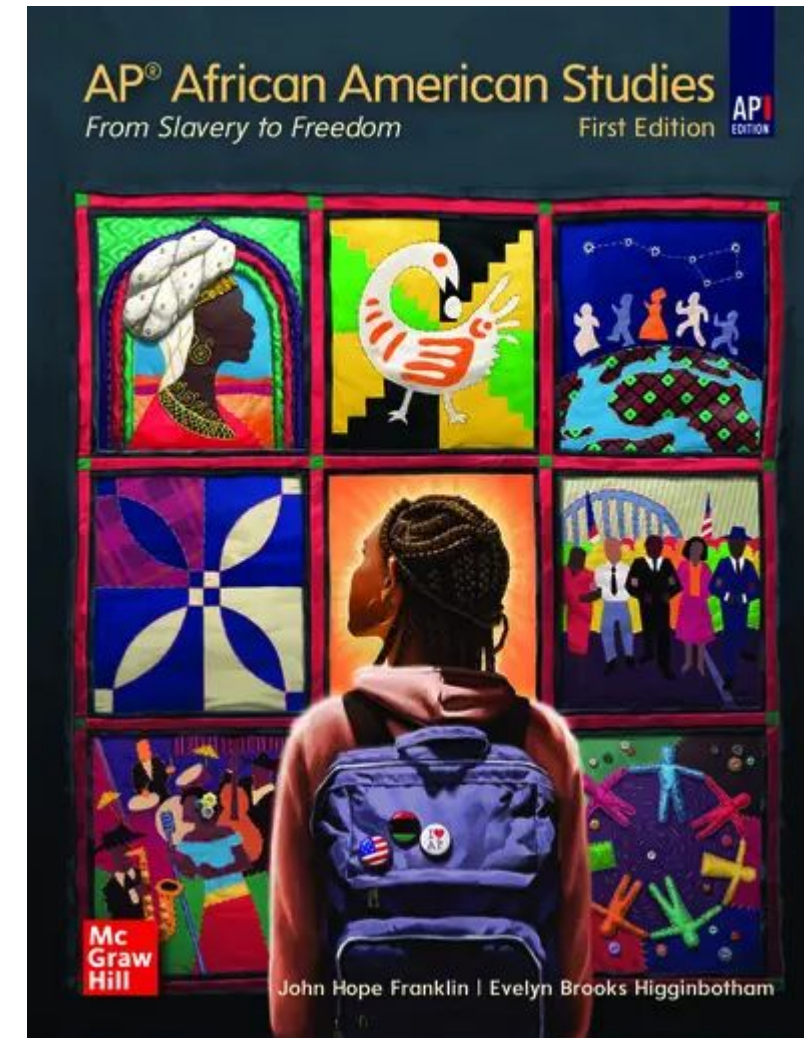

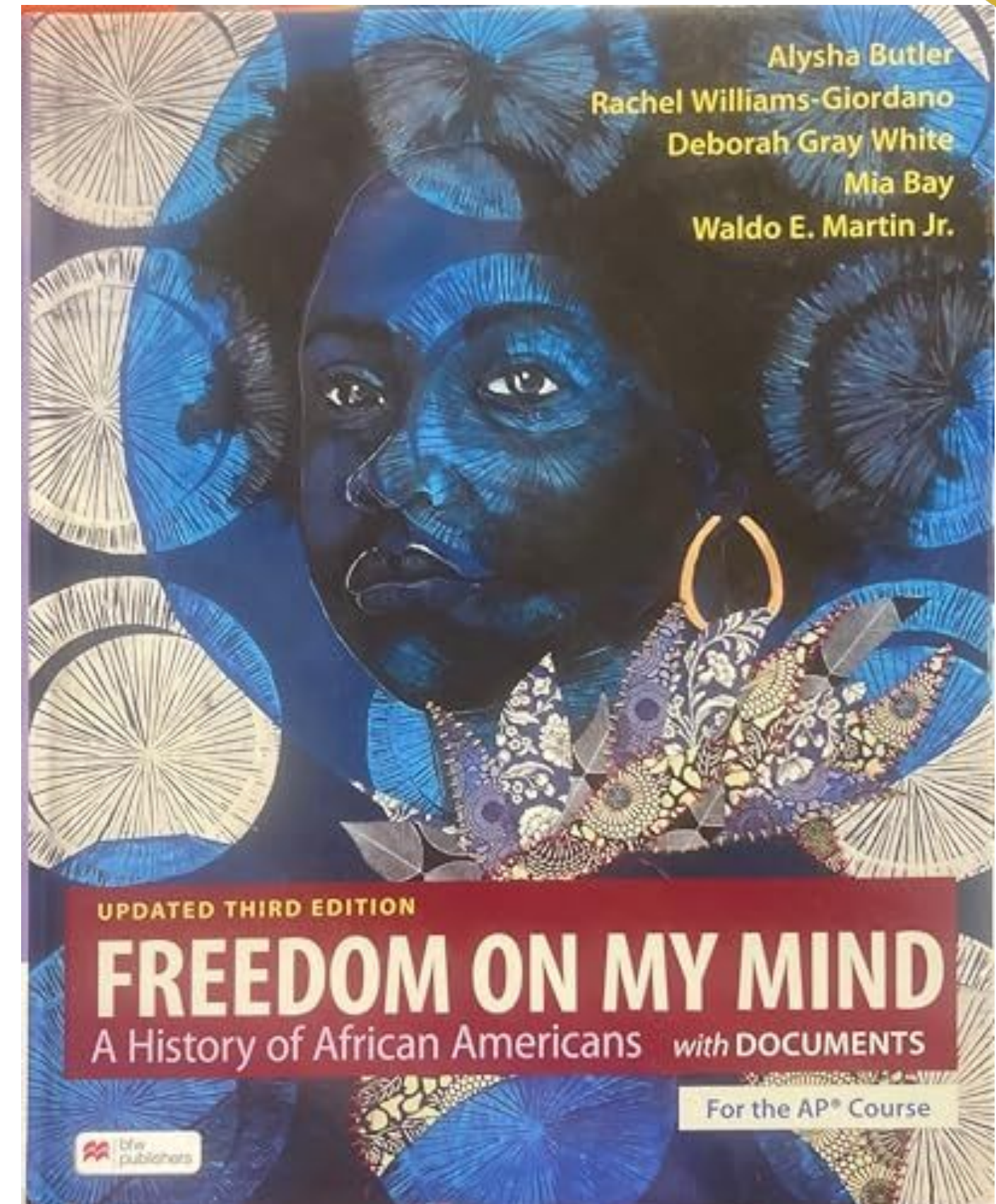

Recommendation

We recommend that the division adopt and purchase:

- ***Freedom on my mind: A history of African Americans with documents for the AP Course*** (Butler et al., updated 3rd edition, 2025)



Rationale

- Strongly aligned with College Board curriculum and examination.
- Received the highest score of all reviewed textbooks from all committee members, especially regarding student accessibility and overall usability.
 - It was the **only reviewed textbook that received A's** (Adequate) in every category from every committee member.
- Offers a wide range of diverse perspectives both in content and authorship.
- Offers a variety of supplemental materials for both teachers and students to help prepare them for success on the AP exam.

Rationale Continued...

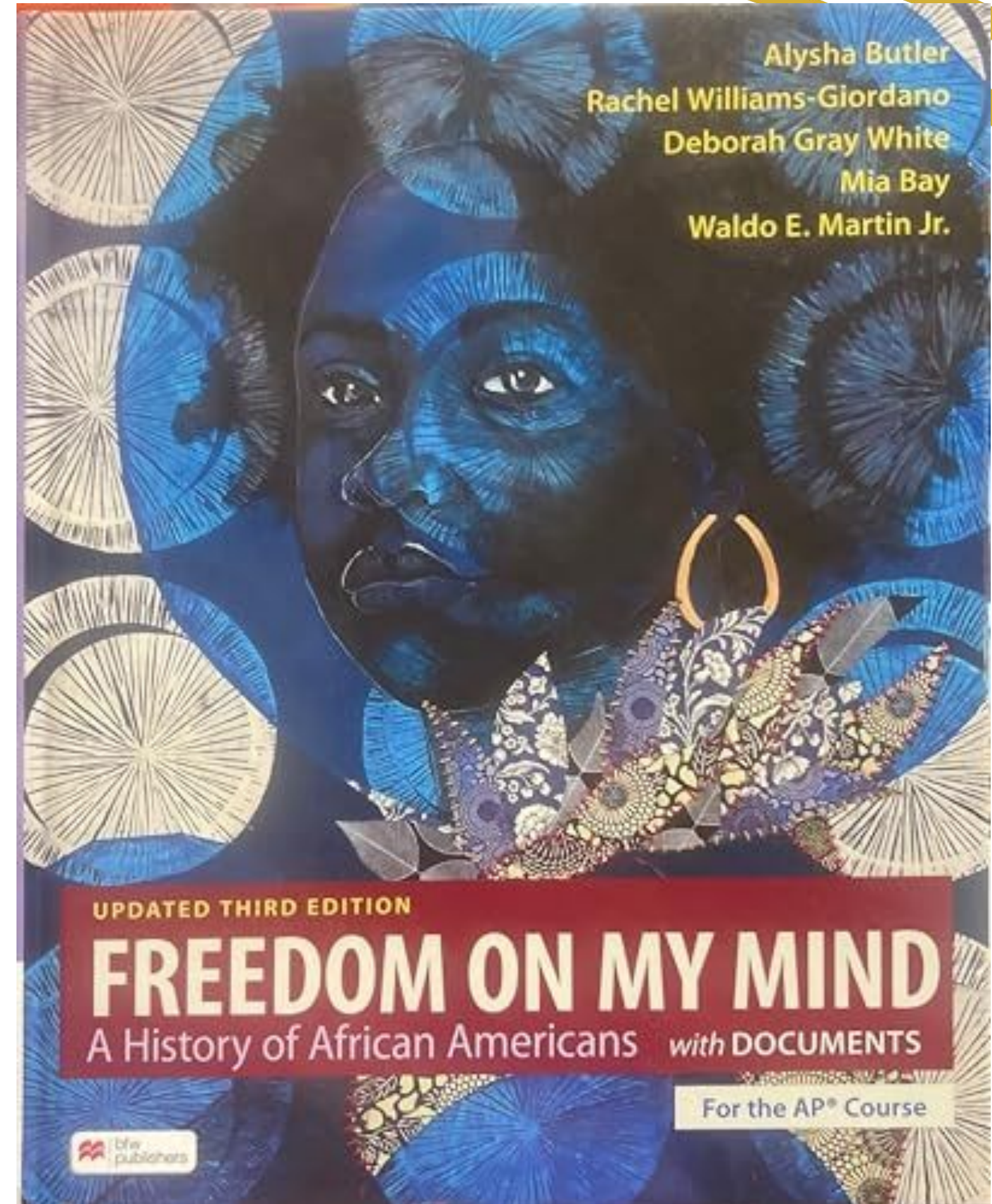

Anticipated Cost

- CHS anticipates having two sections of this course for a maximum of **50 enrolled students**.
- The quote for 50 student edition textbooks, 2 teacher edition manuals, and their online hub of teacher resources for the course for both teachers is **\$7,638.91**



Next Steps

- **May 2026: *Initial School Board Discussion***
 - Adoption committee's official recommendation is given to the School Board for approval
- **May 2026: *Community Review***
 - Committee's recommended textbook is shared with public for public comment.
 - Second choice textbook is also shared for public comment.
- **June 2026: *School Board Approval and Purchase***
 - If approved by school board, CHS moves forward with adoption of textbook and the purchase order for the 2026-2027 school year.
